The 2004-2005 year for I.O.W.A. has drawn the attention of the Iowa State Bar Association on a subject that is near and dear to our hearts: MONEY. Or more specifically, the lack of pay parity amongst male and female attorneys in our state. The ISBA president, Nick Critelli, has sent a call to members of our organization and the committee on women and minorities of the state bar to brainstorm about the causes and solutions for the clearly documented disparity between the earnings of men and women in our profession, particularly at the partner level. One proposal is to feature women attorneys in the state bar's current PR campaign. Another proposal is to do a study on why significant numbers of women abandon our profession for other careers--Why is the legal community suffering the drain of talent and expertise from a significant percentage of its qualified professionals? Please send your thoughts and ideas to help further the dialogue on this pay inequity issue.

## Rules of Professional Conduct

As many of you know, the Supreme Court will soon be adopting new rules of professional conduct, based on the Model Code; rather the Model Rules Iowa has had in the past. The process of reviewing and revising the rules has been a lengthy one. The Supreme Court first ordered that the rules be reviewed in 2000. A Committee composed of dedicated attorneys and law professors spent many hours studying this important matter before making a final proposal to the Court in July 2002. Based on the Committee's work, the Supreme Court released its draft of the proposed rules in September 2004. You can view the Court's proposed rules at [http://www.judicial.state.ia.us/model\\_rules/](http://www.judicial.state.ia.us/model_rules/)

The Court's proposed rules differ, sometimes significantly, from the Committee's draft. The Committee's draft, and especially the comments to the rules, represent an enormous undertaking and are an invaluable source of research on the topic of ethics in Iowa, and elsewhere.

The Supreme Court is now seeking comments on its proposed rules. Comments may be submitted in writing or by e-mail to the Clerk of the Supreme Court and may contain a written request to be heard orally. The deadline for comments has been extended until **January 3, 2005**, and the date for oral presentation is set for **January 31, 2005**.

Take the time to review these proposed rules. The new rules will mean many practical changes for Iowa lawyers. It is important for all Iowa attorneys to familiarize themselves with the rules to avoid any ethical violations and to have a chance to voice their opinion in the adoption of these new rules.

## Joint ABA Commission Releases Draft Ethics Rules Revisions Regarding Gifts to Judges

The American Bar Association Joint Commission to Evaluate the Model Code of Judicial Conduct released proposed code revisions governing gifts to judges and judicial attendance at expense-paid seminars.

"The changes that are proposed in our draft terminology definitions and Rules 4.13 through 4.16 would require judges to consider whether a gift would reasonably be perceived as intended to influence performance of judicial duties. Additionally, they would specify items and benefits that in most cases would not be gifts and could be accepted, distinguishing them from those that are gifts that may be accepted but must be publicly reported," said Mark I. Harrison of Phoenix, commission chair. "Finally, it would set monetary limits on the value of items or benefits that could be accepted."

"We are circulating this draft revision of portions of the code to seek comment," said Harrison.

"The joint commission is continuing to review the Code provisions dealing with judicial political activity and election campaign speech, along with the preamble and terminology sections. When we have completed our initial drafting process and received comments on our proposals, we will consider how we can make additional improvements," he said.

Proposed for the code's terminology section is a gift definition that includes, among other things, gratuities, favors, discounts, entertainment, loans or anything of monetary value, but also identifies exceptions. The exceptions include ordinary social hospitality extended by individuals, not corporations, limited to modest items common in the judge's

community; presentation items, such as plaques and trophies that have little intrinsic value; and loans, discounts, scholarships and fellowships or other opportunities and benefits available or awarded on the basis of factors other than judicial status. Also expressly excluded from the gift definition, but addressed separately in the draft rules, are reimbursements for or waiver of travel-related expense and compensation for extra-judicial activities.

Draft Rule 4.13 lists gifts that judges would be free to accept, requiring that they be publicly reported if the value of any single gift or if the aggregated value of gifts from a single source in one year exceeds \$250.



Draft Rule 4.14 would allow a judge to accept from sources other than the judge's employer reimbursement for or waiver of necessary expenses to participate in extrajudicial activities, if doing so would not cast reasonable doubt on the judge's capacity to act with impartiality, integrity or independence. The reimbursement would be limited to actual costs reasonably incurred for travel, food and lodging for the judge and, where appropriate, a spouse or guest. The rule would require public disclosure at least quarterly of any reimbursement or waiver for a single expense exceeding \$100 or for aggregated expenses from the same source exceeding \$100 per year.

Draft Rule 4.15 would permit judges to accept reasonable compensation for permitted extrajudicial activities, such as speaking fees, as long as the amount does not exceed fees for a person who is not a judge, and as long as it would not cast reasonable doubt on the judge's capacity to act with impartiality, integrity or independence.

Rule 4.16 would require judges to report the date, place and nature of any activity for which the judge received compensation, reimbursement or waiver of charges, the source and the value. The report would be required at least quarterly, filed as a public document with the clerk of the court on which the judge serves or in any other office designated by law. When technically feasible, the rule also would require posting the report on a Web site of the court or office.

# Artistic Attorneys

Two Des Moines area women attorneys tell us how they found creative inspiration in poem-paintings and musical composition. ## Jane Robinette: Poem-Paintings



Heal Your Life, by Jane Robinette

In mid-life I have returned to the passion of my youth—writing poems and combining them with color images. In the 1990s, while working for the federal court as law clerk and staff attorney, I found the book *The Artist's Way* which helped me realize the importance of creativity in my life.

Until then, I did not see myself doing what I do today: creating what I call “poem-paintings”—small, abstract, colorful paintings into which I hand-write my own poetry—and showing and selling them in galleries and special exhibits. I eventually quit my court job to pursue other work, but it still took a few years to focus on my own artwork. First, I started an arts/interview project, the Iowa Women Artists Oral History Project ([www.lucidplanet.com/IWA](http://www.lucidplanet.com/IWA)), in which I interviewed 79 women visual artists living in Iowa. Later I coordinated another arts/interview project, Beyond 9-11: The Art of Renewal in Iowa ([www.beyond9-11.org](http://www.beyond9-11.org)), which received grant support from the Department of Cultural Affairs, and featured visual art, writing, and music in response to the events of September 2001.

Now, in addition to my paintings, I do some web design and maintenance\* and other life history interviewing. I cannot see myself returning to the law, but I don't regret the time I spent there. For now, though, having the time and space to devote to my own creative work is most meaningful to me.

My advice: listen to the passion of your youth. Doing so may not completely change your current path, but it probably will enrich your life.

## Renae Angeroth: Musical Composition

Unlike Jane, I have not quit my day job as a staff attorney with the Southern District of Iowa. My musical training consisted of eight years of piano lessons, 1-A Iowa High School band and choir, and a lot of harmonies over the kitchen sink.

Around 1998, I watched a movie about the war in Bosnia. It contained a throw-away line about how the western world cared more about the divorce of Andy and Fergie than the ongoing war in Bosnia-Herzegovina (1992-1995). I wrote a song to reflect this concept.



Then I remembered the story of a mixed-ethnicity couple who were killed when trying to leave Bosnia during the war. With the first song started and this Romeo and Juliet plot, I began to write *Palace of the Fields*, a modern opera about the war in Sarajevo. I studied Bosnian culture and history through books, magazines, and web sites. I even attended a semester of Bosnian language classes. Each new piece of information served as a genesis for a new song.

Although it has been a tedious and long process, this past summer I received a grant from the Iowa Arts Council to record excerpts from the musical.\*\* The compact disc will be used to promote *Palace of the Fields* to schools and organizations who may want to perform part or all of the production. I also plan to have a website for the project; check back later this fall at [www.palaceofthefields.org](http://www.palaceofthefields.org).

One of the books I have appreciated in this process is *Art and Fear: Observations on the Perils (and Rewards) of Artmaking* by David Bayles and Ted Orland. I believe the authors were writing every chapter for me. If you want to do anything creative, I recommend this book.

As you may know, Iowa has one of the strongest and most active mock trial programs in the country. Close to 4,000 students participate each year. Teachers and parents encourage students to participate in this unique learning experience that teaches essential communication and thinking skills. Because of the continued growth and interest in this educational program, we are asking ISBA members to work with area middle and high school teachers to help in this law-related experience.

We are writing to you today to invite you to sit as a judge at a regional or state mock trial tournament during the 2004-2005 school year. In order to be effective, law-related programs like mock trials require the participation and support of legal professionals. Your role as a judge brings your legal training and expertise to the classroom and helps teach students about law and trials in America. You do not have to be a trial attorney in order to participate as a mock trial judge. You will be asked to assess student performance as they take on the roles of attorneys and witnesses. # National Conference Of Women's Bar Associations

In August 2004, I was elected to serve on the Board of Directors for the National Conference of Women's Bar Associations ("NCWBA"), during the Annual Meeting of the American Bar Association in Atlanta, Georgia. The NCWBA is an organization for women's bar associations. It provides a national forum for exchanging ideas and information vital to organizational growth and success in today's profession.

The NCWBA Board gathers three times during the year at the ABA Annual Meeting in August, the ABA Mid-Year Meeting in February, and in October, to exchange ideas and foster connections between the leadership of women's bar associations throughout the country and abroad. Each year, during the ABA Annual Meeting, the NCWBA holds the NCWBA Bar Leadership Summit, where representatives of state and local women's bar associations of all sizes share ideas for improving organizational structure, programming, and effectiveness.

The NCWBA provides a listserv to Member bar leaders for business referrals, job posting, and information on matters of concern to women in law. In addition, the NCWBA provides a newsletter to share news of significance to women's bar associations.

On August 6, 2004, Miki McGovern and I attended the Annual NCWBA Bar Leadership Summit, "The Secrets of Our Success". During the Summit we met

with women bar leaders from across the country. We discussed women's bar projects, networking/rainmaking opportunities for members, signature events and celebrations for women's bar associations, and unique programs and projects, including CLE presentations focusing on judicial elections, opportunities for youth in the legal profession, membership recruitment, strategic planning, and fundraising and sponsorship. The next Summit will be held in Chicago, on August 5, 2005, during the ABA Annual Meeting.

On October 1 - 2, 2004, the Board of Directors for the National Conference of Women's Bar Associations met in Boston, Massachusetts for a two-day retreat. Michael Greco, the President-Elect for the American Bar Association came as a guest to the Board meeting on Friday, October 1, 2004. Mr. Greco recently served on the ABA Commission on Women in the Profession and is committed to working on women's issues during his presidency. At the meeting the Board worked on developing a new strategic plan. Surveys will be sent to member organizations of the NCWBA in November. The Board will analyze the surveys at the February Board meeting in Salt Lake City in crafting the strategic plan for the NCWBA.
