Each year, I.O.W.A. gives two awards, the Arabella Mansfield Award and the Gertrude Rush Award. Arabella Mansfield, also commonly known as Belle Babb Mansfield, was the first woman lawyer admitted to the practice of law in the United States. Gertrude Rush was the first African-American woman to be admitted to the practice of law in Iowa in 1918.

#### **Judicial Nomination**

I.O.W.A. advocates for more women on the bench and in leadership positions in other bar associations. The group monitors vacancies in those positions and encourages its members to apply for judicial positions and to support qualified women candidates.
